Oral Communications

Mr. Wiggins called for oral communications at this time.

Citizen Comment Appearing to comment were Barbara Langford, thanking the City for holding a neighborhood watch meeting in her neighborhood and thanking the Burbank Foursquare Church for hosting the meeting, and supporting the plans for the South San Fernando Project Area; Sister Lucille Dean, Sisters of Providence, on the history and importance of Providence St. Joseph Medical Center in the Burbank community, on the quality of services provided by the hospital even in the midst of a large expansion of their services, on the charity work provided by the hospital, and requesting the Council/Agency to approve the financial assistance for the water main upgrade; Tom Bruehl, on the required expansion of Providence St. Joseph Medical Center, on the community support of the hospital, on the benefit of the hospital to the community, and requesting the Council/Agency to approve the financial

assistance for the water main upgrade; Don Elsmore, announcing the Airport Authority will have a quarterly meeting on Thursday, on the impacts of conservation mandates on the electric rates, and on concern with a member of the Landlord Tenant Commission noting she is not supportive of low rental rates and noting his belief that large apartment complexes increase rental rates without providing improved facilities; Frank Kaden, on concern with Cayman Development building two guard gates at their housing project, on concern with the condition of the streets on and around Alameda Avenue, and on concern that there is an appearance of a conflict with the City's special counsel for the Airport who also represents Los Angeles Airport; Mark Barton, on concern with racist statements made by public speakers; Irma Loose, on her belief that a restraining order filed by a Council Member is City business; Sunder Ramani, representing the Burbank Chamber of Commerce, stating the Chamber would like to be the conduit to conduct a Candidate Forum for the April 10, 2001 City Council runoff, noting all four candidates have agreed to participate in the Forum, and asking the Council to approve their request to conduct the Forum on Channel 6;

Robert Ross, asking the Council to reveal the costs of the case filed by Irv Rubin against the City for their invocation; Esther Espinoza, on concern with the Council candidacy of Dave Golonski and Marsha Ramos, and on concern with two complaints filed with the Equal Employment Opportunity Commission by City employees; LaVerne Thomas, on an article in the newspaper in 1984 related to community activists, on concern with the City's outside counsel for the Airport also representing the Los Angeles Airport, and on concern with the City's Housing and Transportation Elements being outdated; C. L. Stack, on the importance of a Candidate Forum for the Council runoff in April, and on concern with any expansion of the Airport and as such supporting the candidacy of Howard Rothenbach due to his involvement with the Restore Our Airport Rights (ROAR) initiative; Howard Rothenbach, on the validity of the ROAR initiative and opposing the Council submitting the initiative for a report as allowed by the Election Code; R. C. "Chappy" Czapiewski, opposing the Council submitting the ROAR initiative for a report, presenting the Council with a public records request to inspect records on a decision made in the Court of Appeals for the City to recover costs related to the Airport, and playing a videotape of a press conference which revealed the Framework for Settlement Agreement for the Airport and asking why Council Members Golonski and Murphy did not discuss the Framework in their candidate statements in the Sample Ballot; Ted McConkey, on concern with who was contacted to conduct the Candidate Forum and opposing the recommendation that the newspapers be asked to assist City staff in conducting the Forum and supporting the 8-Ball Welfare Foundation conducting the Forum, opposing the financial assistance to Providence St. Joseph Medical Center, opposing the Council requesting a report on the ROAR initiative, and asking for an update of the status of the Airport; Bob Etter, asking whether an accidental landing at the Airport would incur a fine, asking if the street cleaners water usage is monitored, opposing the structure of the Youth Endowment Services Fund, and opposing the financial assistance to Providence St. Joseph Medical Center noting concern with the quality of services they provide to the community; and David Piroli, asking the Council to direct staff to prepare the ordinance calling a special election for the ROAR initiative, on concern with statements made by a speaker at the podium but noting his belief that people should have freedom of speech, and stating his belief that a restraining order is City business.

Staff Response

Members of the Council and staff responded to questions raised.

8:05 P.M. Recess

The Council recessed to permit the Redevelopment Agency to hold its meeting. The Council reconvened at 8:25 p.m. with all members present.

The Council recessed at this time. The meeting reconvened at 8:43 p.m. with all members present.

1503 Conservation Measures for Electric Reliability and Cost Savings Mr. Simay, Assistant General Manager, Burbank Water and Power (BWP), reported that the City needs to undertake conservation efforts for the following reasons: they will help minimize rate increases; they comply with the Governors Emergency Orders for localities to reduce electric consumption in City facilities by 7 to 10 percent; and, benefits the environment and the pocketbook. He then said that BWP has three main conservation goals: to reduce Burbank's summer 2001 peak demand from an expected 290 megawatts (MW) to a targeted 260 MW; reduce peak demand by 10 percent, or 30 MW; and, to reduce Burbank's Fiscal Year 2001-02 energy

consumption from an expected 1164 million kWh to a targeted 1082 million kWh. To achieve these goals, he noted that the City departments are committed to setting a good example, appeals will be made to the community, and expanded conservation programs will be offered.

At this point he introduced Mrs. Meyer, BWP Marketing Manager, who discussed the following conservation programs to be implemented immediately by the City; City employees urged to lead the way through memorandums and signage stressing the urgency of conservation as well as workshops and report cards; shut down air conditioning and lighting in unoccupied and limited occupancy City facilities during weekends; set temperatures to 76 degrees in City facilities; install timers on ball field lights; use LEDs for traffic lights; have BWP pump water off-peak; and, install energy efficient lighting and heating and air conditioning ventilation.

Next, she said that the Governor ordered that lighting be reduced by 50 percent after-hours. She said that in response to this order, a memorandum will be sent to all Burbank businesses asking for a commitment to reduce the late night lighting. She noted that the Burbank Police Department is able to assist customers with safe lighting level recommendations.

Mrs. Meyer then discussed several proposed programs for Council consideration that would aid in Citywide conservation efforts: 1) Energy Star Program which would include rebates to customers for purchasing new energy efficient appliances; 2) Residential giveaway of compact fluorescent lights (CFL) by distributing coupons to all Burbank households for redemption of two CFLs at selected City facilities; 3) Rebates to residential and small business for installing HVAC units exceeding Title 24 standards; 4) Offer swimming pool owners an incentive for setting their pool pump timer to operate four to six hours during off-peak hours; Cool roof program which is a roof coated with or covered by specific materials that both reflect solar rays and emit much of their own heat; and, 5) Green power which allows customers to purchase a portion of their power through BWP in support of renewable resources.

Following discussion, the City Council stated their support for expansion of Burbank Water & Power's (BWP's) conservation program to include the following elements: customer communications will use Customer Services and a multimedia

approach; use moral suasion to induce compliance with the Governor's emergency order; continue to pursue seasonal time-of-use (TOU) rates for BWP's largest customers; explore the adoption of inverted rates for residential and small business customers; expand economic inducements to conserve; and add economic inducements for customers to use renewable sources.

For the coming fiscal year, staff will also be recommending specific conservation expenditures that upgrade the energy-efficiency of City facilities or end uses like lighting and HVAC. In addition, staff will be recommending that there be a solar heating demonstration project for the McCambridge Park swimming pool.

1501-1 Presentation on Current Gas Situation Mr. Norman Pederson, special outside counsel with Jones, Day, Reavis & Pogue, reported on the recent request from Vice Mayor Kramer for an outside party to discuss the 2001 natural gas price and transmission capacity issues. He began by stating that natural gas prices have skyrocketed in the last year to a point that no person would ever have anticipated. He noted that the increase to the California border has been the highest due to the way gas is transported into the State, which is done through six production points, as well as the demands placed on the delivery system.

He explained that the total delivery system capacity in California is 3,500 million cubic feet per day. Historically, he said the system has been able to meet demand with an average 20 percent slack. However, he said the demand on the system began to increase last spring and is currently 100 percent of the system capacity. Thus, he noted that this summer, the transmission system will be operating at capacity for 2001 and into 2002.

To deal with the system capacity needs, Mr. Pedersen said the interstate pipelines have intervened in the situation and are proposing expansions at Kern River and El Paso. However, he noted that SoCal Gas has stated that despite 2001 conditions, no expansion is warranted based on historical forecast utilization of their firm backbone.

The City Council received the report.

Mr. Golonski Left the Meeting with the following matter since he is currently a candidate in the General Municipal Election.

204 204-3 102-3 Candidate Forum For the April 10, 2001 General Election Mrs. Sarquiz reported that following the Primary Nominating Election on February 27, 2001, staff asked the League of Women Voters, who conducted a Candidate Forum on February 3, 2001 for the Primary Election, to consider conducting a Candidate Forum for the Council run-off at the April 10, 2001 General Election. She said that the League, following a board meeting, informed staff that they were not interested in conducting the Forum due to their current involvement in conducting one for the upcoming City of Glendale election.

Next, she explained that on March 9, 2001, the City Council received a written request from the Burbank Chamber of Commerce to conduct the Candidate Forum for the City. In a letter she said the Chamber stated that they will assume the organizational efforts and will ensure that the Forum is non-partisan and fair to all. Further, she said they asked that the City consider cooperating in their effort to conduct the Forum by providing either live coverage on the community channel with rebroadcasting or rebroadcasting alone. Additionally, she noted that the following organizations expressed verbal interest in conducting a Forum: 8-Ball Welfare Foundation, an independent wing of the Greater Los Angeles Press Club, the Burbank Leader, and the Tolucan.

Mrs. Sarquiz discussed that pursuant to City Council Resolution No. 24,471, no organization that endorses candidates or supports local measures is allowed to sponsor a candidate forum. She said the Burbank Chamber of Commerce has said they are a non-profit organization that does not endorse candidates at the local, state or federal level, but do support or oppose measures similar to the League of Women Voters. She noted that it is staff's understanding that the 8-Ball Welfare Foundation and the Tolucan also do not endorse candidates or take positions on measures. However, she said the Burbank Leader does endorse candidates and take positions on measures.

She concluded by stating that the Council had the following options related to the Candidate Forum: determine whether or not to work with one of the organizations to conduct the Forum; direct the City Clerk and Public Information Office to conduct the Forum and call upon outside parties to assist; or,

determine that a Candidate Forum not be held. She then noted that in a separate memorandum, the City Manager has recommended that the Council direct the Public Information Office to handle all of the logistical arrangements of the Forum and invite each of the three newspapers of general circulation in town, the Burbank Leader, Daily News, and Los Angeles Times, to oversee the content of the Forum.

Motion

It was moved by Mrs. Murphy, seconded by Mr. Laurell and carried with Mr. Golonski absent that "the Chamber of Commerce be selected to work with the Public Information Office to conduct the Candidate Forum and that the City provide the Council Chambers to hold the Forum and provide live coverage and rebroadcasts of the Forum."

204 406 ROAR Certification

Mrs. Sarquiz reported that on January 30, 2001, Howard Rothenbach, Restore Our Airport Rights (ROAR) Committee Chairman, presented the City Clerk's Office with petitions containing approximately 10,928 signatures. She noted that the initiative was circulated beginning on August 18, 2000 and ending on January 30, 2001.

She explained that following a review of the petition by the City Clerk and the City Attorney on February 2, 2001, the petitions were delivered to the County of Los Angeles Registrar-Recorder/County Clerk for verification of the signatures. She noted that a 100 percent verification of the petition was conducted.

Mrs. Sarquiz discussed that the circulators had the option of collecting 10 or 15 percent of the signatures of the 51,085 Burbank voters who were registered at the time the petition's notice of intent was published. She said that meeting the 10 percent (5,109) threshold would require the City Council to place the measure on the next regular election in 2003. She then said that meeting the 15 percent (7,663) threshold would require the City Council to place a measure on a special election to be held not less than 88 days or as soon after six months from the last special election conducted in the City.

According to the certification received on March 13, 2001

from the County Registrar-Recorder/County Clerk, out of the total of 10,865 signatures verified, 3,051 were not sufficient with the remaining 7,814 signatures being sufficient. Thus, she noted, the initiative has qualified for a special election. Mrs. Sarquiz concluded by stating that since the petition has been certified by the County and the results presented to the City Council, the Council has three options: 1) The Council may direct staff to prepare an ordinance, within 10 days, that would adopt the ROAR initiative without alteration; 2) The Council may direct staff to have a report on the effect of the initiative prepared pursuant to California Election Code Section 9212; or, 3) The Council may direct staff to return within two weeks with an ordinance exploring all options that would put into place the calling of the special election.

Motion

It was moved by Mrs. Murphy, seconded by Mr. Kramer and carried that "staff be directed to have a report prepared pursuant to State Election Code Section 9212 to be returned within 30 days and a decision made on how to proceed within 10 days."

906 Neighboring Cities Response To Rent Hikes A report was received from Mrs. Georgino, Community Development Director, in response to a recent request from Council Member Golonski to have a report presented to the Council on neighboring cities' responses to rent hikes. In response to the request, the report stated that staff conducted a survey of nine cities including: Glendale, Inglewood, Lake Forest, Lakewood, Norwalk, Pasadena, Thousand Oaks, West Lake Village and Whittier. The report noted that none of these cities has initiated any rent control measures, however, Glendale's Housing Authority has authorized its staff to study the current rental housing market and the impacts of recent increased rents on Glendale's housing programs. Glendale is currently working on several strategies to formulate a set of recommendations.

The report stated that if the Council desires having staff prepare a report that includes a study on the prospects of implementing a rent control ordinance, at least seven to nine months is necessary to adequately conduct research and analysis.

Motion

It was moved by Mr. Golonski, seconded by Mrs. Murphy and carried that "staff be directed to conduct a study, similar to and in conjunction with Glendale, that studies the current rental housing market and the impacts of recent increased rents on housing programs and work on several strategies to formulate a

set of recommendations."

102-3 Selection of Host for Animal Shelter Cable TV Show Police Chief Hoefel reported that for a number of years the Public Information Office has been producing a weekly show from the Burbank Animal Shelter which has been extremely well received by the community and is at least partially responsible for the outstanding record of pet adoptions.

He explained that Vice Mayor Bob Kramer has been the host of the show for essentially its entire history but since he recently ran for City Treasurer, he was unable to host the show. He noted that Council Members Golonski and Murphy were running for re-election to the City Council and as such were also ineligible to host the show. Thus, during that election season, he said that Mayor Wiggins and Council Member Laurell served as hosts of the show.

Police Chief Hoefel concluded by stating that since the Primary Nominating Election was now over, it was a perfect time for the City Council to review the hosting of the show. He noted that although it is unknown which Council Members are desirous of hosting or co-hosting the show, staff always stands ready to provide hosts for any edition for which no regular host is available.

Motion

It was moved by Mr. Laurell, seconded by Mrs. Murphy and carried that "until the Public Information Office returns to the Council with options for the continuation of the Animal Shelter Show, Council Members Laurell, Murphy, Wiggins and Kramer (and the newly elected Members following the April 10, 2001 General Election) co-host the Show on a rotational basis and when they are not available either Captain Bowers or Chief Hoefel would be the substitute hosts, and whenever the Public Information Office returns with the options, the Council will take action at that time."

1301-3 2001 Sidewalk Repair Project (B.S. 1080) A report was received from Mr. Feng, Public Works Director, which requested City Council approval of contract documents and award of a construction contract with C J Construction Company in the amount of \$231,220 for Bid Schedule No. 1080, the 2001 Sidewalk Repair Project. The report noted that the City has an annual sidewalk repair program to maintain the concrete improvements within the City's street right-of-way.

Mr. Barlow stated that this matter was postponed from the

March 13, 2001 City Council meeting due to the fact that several Council Members were concerned with a potential conflict of interest with the matter due to the fact that their residences were within 500 feet of the project area. He said that following research into the matter, he found that the State law said that although the general rule is that when a Council Member is within 500 feet of the project there is a presumed conflict of interest, there is some specific exceptions to that presumption where you have a maintenance or repair project which is exactly the type of work contemplated in this Bid Schedule. Thus, he said there would not be a conflict and all Council members can participate in this decision.

Citizen Comment

Appearing to comment were Mark Barton, on concern with racist comments made by speakers at the podium; Irma Loose, supporting the 21st Century Plan for the Airport and opposing the Framework Agreement, on concern that Measure B, which requires a vote of the people for any Airport expansion or terminal relocation, is misleading, and supporting Restore Our Airport Rights (ROAR); Bill Orr, stating how difficult it was to get signatures for the ROAR initiative and suggesting the Council would be more fiscally responsible to just adopt the initiative rather than holding the election at a cost of \$80,000; Bob Etter, stating his belief that Council Member Golonski owns the Youth Endowment Services name, stating his belief that Vice Mayor Kramer should host the Animal Shelter Show, and on concern with the dirt being removed from a project near Olive Avenue noting the dirt on the streets is going into the storm drains; Fred Haas, on concern that the businesses will have to install security gates for protection in the evenings due to the electrical shortage and the Governor's order that lights be turned off in the evenings; Esther Espinoza, on concern that the City government does not have adequate minority representation; and, Howard Rothenbach, stating his appreciation for the presentation on the gas issues, and supporting the ROAR initiative going to the electorate immediately.

Staff Members of the Council and staff responded to questions Response raised.
