804-3 801-2 Battery Back-up Systems for Traffic Signals Mr. Johnson, Assistant Public Works Director-Traffic Engineer, stated the purpose of this item was to request Council approval of a resolution authorizing an agreement with the California Energy Commission (CEC) for a traffic signal battery back-up systems (BBS) grant at twenty intersections and approval of a resolution to seek additional funding for the

installation of an additional nine traffic signal BBS. displayed a map depicting the proposed approved locations as well as the additional BBS locations. He identified the advantages of the BBS, including that the BBS frees up Police Department and Public Works Department personnel, improves safety at intersections near schools and improves vehicular He noted the grant amounts and project totals, including a \$53,200 grant at the twenty approved locations, plus \$26,800 in City matching funds, totaling \$80,000; and a \$26,300 grant, plus \$13,300 in City matching funds, totaling \$39,600 for the additional locations. Next, he addressed the significance of installing the Light Emitting Diod (LED) signals, and explained how the annual energy savings will pay for replacement of the batteries, as the use of LEDs saves about \$230,000 annually in energy costs, and battery replacement will cost \$5,000 annually for all 29 locations.

# 406 Comprehensive City Policy on BGPA Facilities

Mrs. Georgino, Community Development Director, stated that several months ago the City Council initiated a public outreach program designed to educate the public on airport development issues and began an effort to develop a broad consensus aimed at creating a comprehensive strategy for airport development. She noted several noteworthy events relating to the Burbank Airport have occurred in recent months, including the conclusion of the Measure A litigation, the completion of the Plan Evaluation and Review Committee (PERC) process, the City Council's adoption of the interim development control ordinance (IDCO), and staff's approval of the Airport security project. She stated the PERC report was developed at the conclusion of a focused public outreach

effort and was drafted by a subcommittee who presented the report on October 1, 2002, noting the inclusion of the minority opinion in the report. She continued that the report provides a series of recommendations aimed at addressing the quality of life issues impacted by the operation of the Airport, and that the Council directed staff to develop a program utilizing the report as a basis for examining options and making recommendations for the appropriate zoning and development standards for properties currently under the jurisdiction of the IDCO, and that in addition the Council indicated the report would be used in future discussions with the Airport Authority and the cities of Glendale and Pasadena as potential options would be developed both for the operation of the existing terminal and any future terminal.

Mrs. Georgino stated there is both a need and an opportunity to build upon these efforts to construct a comprehensive, enforceable City policy on the Airport that establishes the criteria and conditions for either expanding existing facilities or constructing new facilities, and, based upon staff's belief that the community needs to prepare for several options for future Airport facility projects, recommended the initiation of a process to develop a comprehensive City policy for Airport facilities. Next, she outlined the purpose of such a policy, as follows: protects the quality of life for Burbank residents; has the express approval of the voters; is comprehensive in its scope; incorporates and reflects several alternate visions of the Airport's future; and is practical, capable of being implemented, and enforceable through specific laws and other mechanisms.

Mrs. Georgino noted the two key ingredients of such an undertaking include that the process be transparent so that all interested stakeholders are able to see how the policy is being developed and participate in its drafting, and, secondly, the policy must set achievable goals, striking a balance between competing interests and legal rights. She proposed the development of a comprehensive policy on Airport facilities involve the following elements and phases: implementation of PERC recommendations; development of a Specific Plan; development of a City Policy on Airport Facilities; presentation of a ballot measure seeking voter ratification of the City Policy on Airport Facilities subsequent to voter ratification.

Mrs. Georgino stated the timing for this effort is tight and that the expiration of the IDCO in August 2004 should set the outer limit for completing implementation of the Policy, and recommended the effort be led by City staff in coordination with the planning and communications firm of Moore Iacofano

Goltsman, Inc. (MIG), who would be assisted by the City's outside airport counsel and who would retain experts in at least the disciplines of traffic, environmental review, economics and noise, adding that the expert would provide substantive advice both on the elements of the specific plan and on practical drafting and implementation of the Policy. Mrs. Georgino introduced Patricia McLaughlin, one of the principles of MIG, who participated in the PERC process and served as the primary recorder of PERC sessions. Ms. McLaughlin introduced Steve Reiner, Director of Community Development Services for MIG and has 30 years of planning experience in the implementation of general plans, specific plans and community development projects.

Mr. Reiner described the Specific Plan as a planning tool which allows the City a response to possible alternatives related to airport development and would be geared towards protecting the quality of life for residents; allows the City to comprehensively look at immediate and adjacent airport lands to study current land, economic, and environmental issues in a way which documents current conditions; and, identifies possible future alternatives for development. He added that in concert with consulting the community, specific plans are a highly flexible tool that have been used as a means of addressing the future.

Mrs. Georgino discussed the proposed schedule for the Burbank Airport Policy project, and displayed a map of the Burbank Airport Specific Plan Study Area.

It was moved by Mr. Vander Borght and seconded by Ms. Murphy that 'staff be directed to proceed with the outreach effort, proceed with the study of the land use standards, proceed with the Specific Plan process to clarify the scope of the work, excluding entering into any contracts for this purpose, and to bring back a report addressing the concerns expressed by the Council with the proposed approach, including the implementation of the PERC recommendations, in a study session format."

701 Overview of State Library Const. and Renovation Bond Act

Sharon Cohen, Interim Library Services Director, stated the Buena Vista Library represents an outstanding example of library service in the rew millennium, but also serves to call attention to the inadequate conditions at the City's other two library facilities, the Central Library and the Northwest Branch Library, and staff is focusing on identifying the needs at these two other facilities. She reported it has always been the City's goal to eventually replace the existing buildings with new facilities so that every resident in Burbank can benefit from a higher level of library services, and noted the State's Library Bond Act of 1999 provides an incredible opportunity to make this goal a reality by authorizing the awarding of library construction grants on a competitive basis for new or expanded library facilities through an allocation of \$350 million to be distributed to public libraries in three rounds over a three-year period. She noted the first round closed in June 2002, the second round is scheduled to close in March 2003, and the final round is scheduled to close in January 2004. She added the maximum grant per project is \$20 million, with the State funding 65 percent of the cost of constructing new or expanded public library facilities, while the grant applicant must identify a local funding match for the remaining 35 percent at the time of application. Mrs. Cohen stated it is the Burbank Public Library's intention to apply for a grant in the second round to construct a new Central Library at the site of the former Fire Station on Olive Avenue, and that, pursuant to a Professional Services Agreement with Charles Walton Associates to assist in the planning and architectural steps required of applicants for construction grants, Steve Finney, President of Charles Walton Associates and architect of the Buena Vista Library, has been working to determine the footprint of a proposed Central Library. She summarized the establishment of the Burbank United in Library Development (BUILD) Committee and noted its charge was to assist in a Library needs assessment and to study available funding mechanisms that would allow the City to raise the 35 percent required funding to apply for State grant funding.

Mrs. Cohen then introduced Vic Georgino, BUILD Committee member and Chair of the BUILD Finance Sub-committee. Mr. Georgino requested Council support for the construction of two new libraries, the Central Library located downtown, and the Northwest Branch Library located near Hollywood Way and Victory Boulevard. He outlined the Finance Sub-committee's plan to achieve this goal, including that the City would apply for a Library Construction Grant which would provide for the construction of a new Central Library during the second round of allocation. Mr. Georgino reported that it was the Committee's recommendation to rebuild the Northwest Branch

Library, and that the Committee has proposed a bond measure which, if approved by the Council, will be consolidated with the February 25, 2003 Primary Nominating Election, noting the implementation of this bond would be contingent upon the City receiving two-thirds approval by voters to pass the bond measure. He indicated the goal was to keep the debt service at a maximum level of \$12 per year per \$100,000 assessed value, noting residential property owners will actually pay only seventeen cents on the dollar with the balance coming from commercial property. He stated the appointment of a Financing Team is necessary to expedite the requirements associated with the ballot measure, adding that the Committee recommended including the cost for rebuilding the Northwest Branch Library as part of the bond measure and a communications consultant to assist in the local match methodology. He reported that the Friends of the Burbank Public Library and the BUILD Committee agreed to partner in the effort to construct two new libraries, and the Friends voted to assist with the funding of the campaign effort, once the measure is approved for the ballot.

Mrs. Cohen introduced Mr. Finney, President of Charles Walton Associates, who addressed the library facilities needs, and Mr. Hanway, Financial Services Director, who summarized the need to appoint a finance team for the general obligation Mr. Hanway stated it is to the City's benefit to bonds. appoint firms with experience in the issuance of general obligation bonds, as well as familiarity with the City, and recommended Peter Ross, Ross Financial, as the proposed Financial Advisor, and Brian Quint, Quint & Thimmig, as proposed Bond Counsel and Disclosure Counsel, noting compensation for the Financing Team would be paid as part of the bond issuance costs, if bonds are issued. Mr. Hanway recommended the appropriation of up to \$25,000 for a communications consultant to look at the ballot language and assist in the development of the ordinance which will be brought to the Council later in November.

201 204 City Council Compensation Mr. Nicoll, Management Services Director, requested Council consideration of an ordinance seeking voter approval of Council compensation. He briefly summarized that the law allows Council salaries to be increased up to five percent per year, and in December of 2000 the Council directed staff to prepare an ordinance to be placed on the ballot to determine Council compensation, and such compensation was increased by 5 percent in 2001 and it was established that any increase provided in 2002 would be based upon the Consumer Price Index (CPI), which resulted in a 2.8 percent increase. Staff was also instructed to bring back an ordinance in 2002 for the purpose of determining Council compensation.

Mr. Nicoll presented the following options for Council consideration: 1) direct staff to prepare an ordinance that proposes a one-time solution allowing the electorate of the City to determine if the compensation for City Council Members should be raised by five percent to \$998 effective May 1, 2003; or 2) direct staff to prepare an ordinance which would provide an on-going solution either by automatically increasing Council compensation annually by five percent, as allowed by law, or allowing an annual increase tied to an economic indicator, such as the CPI.

She stated the Primary Nominating Election will nominate or elect candidates for terms of four years for two offices of Member of the City Council and three offices for Member of the Board of Education. She noted the Charter states that where there is more than one office to be filled, any candidate who receives more than one-half of the votes cast for all candidates for nomination to office at the Primary Nominating Election shall be deemed and declared by the Council to be elected to such office, and that in the event no candidate receives more than one-half of the votes cast for more than one office, a General Election will be required. Mrs. Campos concluded by stating all Municipal Elections shall be conducted and held in substantial compliance with the City Charter, the Burbank Elections Code, and the State Elections Code.
