RA 60 Former Newberry Bldg. (328-330 N. San Fernando)

Mrs. Evans, Assistant Community Development Director, stated that at its previous meeting, The Agency Board approved a Downtown Tenant Assistance Program (DTAP) with a goal of attracting retail tenants into the downtown and filling vacant retail space. Mrs. Evans stated the proposed agreement represents the first application for the DTAP. She outlined the general terms of the program, including to provide financial assistance for structural and tenant improvements for underutilized and vacant properties downtown, provides forgivable market rate loans as financial incentives to attract quality retail tenants to locate in the downtown and that the program is available to retail tenants interested in locating downtown or property owners interested in attracting retail tenants in the downtown area. She noted that on September 24, 2002, the Agency conceptually approved the DTAP and initial funding of \$1.5 million as part of a comprehensive funding strategy to implement the downtown revitalization strategy.

Mrs. Evans further stated that the specific proposal before the Board is for the improvement of the vacant Newberry building. She said the developer is Tucker Investment Group (TIG) and the retailer is Urban Outfitters; the terms of the loan fall within the approved program. The former Newberry Building represents one of the Agency's targeted vacant sites and Urban Outfitters represents an important retail addition to the downtown.

Mrs. Evans then stated that each loan request would be analyzed

and presented to the Agency Board on its own merits using the DTAP general guidelines. She noted the proposal has been reduced from \$75 per square foot to \$50 per square foot and the total leased area increased from 11,000 to 15,000 square feet, with the provision to the agreement that the Agency will share 50 percent of any percentage rents that flow to the owner.

Mrs. Evans reported that in this case, with the Agency loan of \$742,000, the developer's return is approximately 8.5 percent rather than 10 percent from the private market. The real benefit of the project, she noted, is that it acts as a catalyst to bring other retailers to the downtown.

Mrs. Georgino responded to concerns raised during oral comment.

Council Members Golonski and Murphy stated they would not support that great of a subsidy for a single tenant, noting that it represented one-half of the \$1.5 million allocated for DTAP projects. Council Member Golonski stated he would only support a loan of \$500,000.

Mayor Laurell asked Mrs. Georgino she feels there is room for compromise with the applicant.

Mr. Tucker, the developer, was recognized by the Council and stated that he felt Urban Outfitters would be an important catalyst for the downtown, but would not be open to further negotiations; they are on a very tight schedule.
