10:45 P.M. Meeting Continued Following a report, public hearing and the combined oral communications, the Council meeting was recessed to allow the Agency to hold its meeting.

RA 41 Appointment to Burbank Housing Corp. Board of Directors Mrs. Campos, City Clerk, requested the Redevelopment Agency (Agency) Board consider making one appointment for a two-year term on the Burbank Housing Corporation's Board of Directors ending November 1, 2006. She reported that on September 27, 2004, the Secretary's Office began advertising and accepting applications for one vacancy on the Burbank Housing Corporation. She added that the vacancy was advertised in the local newspapers, posted on the City Website and notices were run on the Channel 6 scroll in order to obtain qualified candidates. She noted that as of the October 8, 2004 deadline, one application from Allen Cottriel had been received.

Mrs. Campos explained that the Burbank Housing Corporation was organized to improve and preserve the existing housing inventory in the City of Burbank that is affordable to low-income and moderate-income persons, and to provide community assistance and property management services at existing affordable housing projects within the City.
